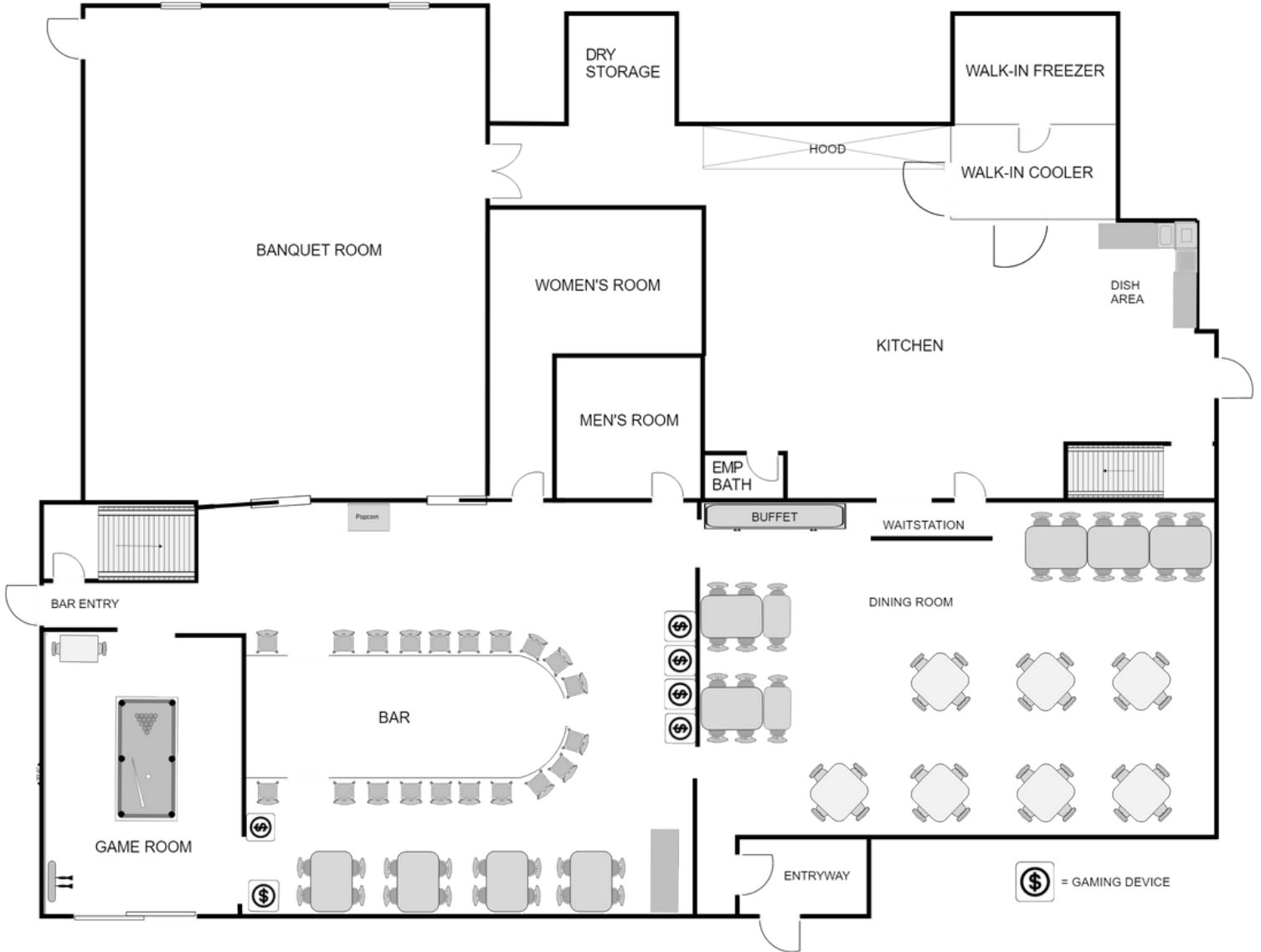

FLOOR PLAN

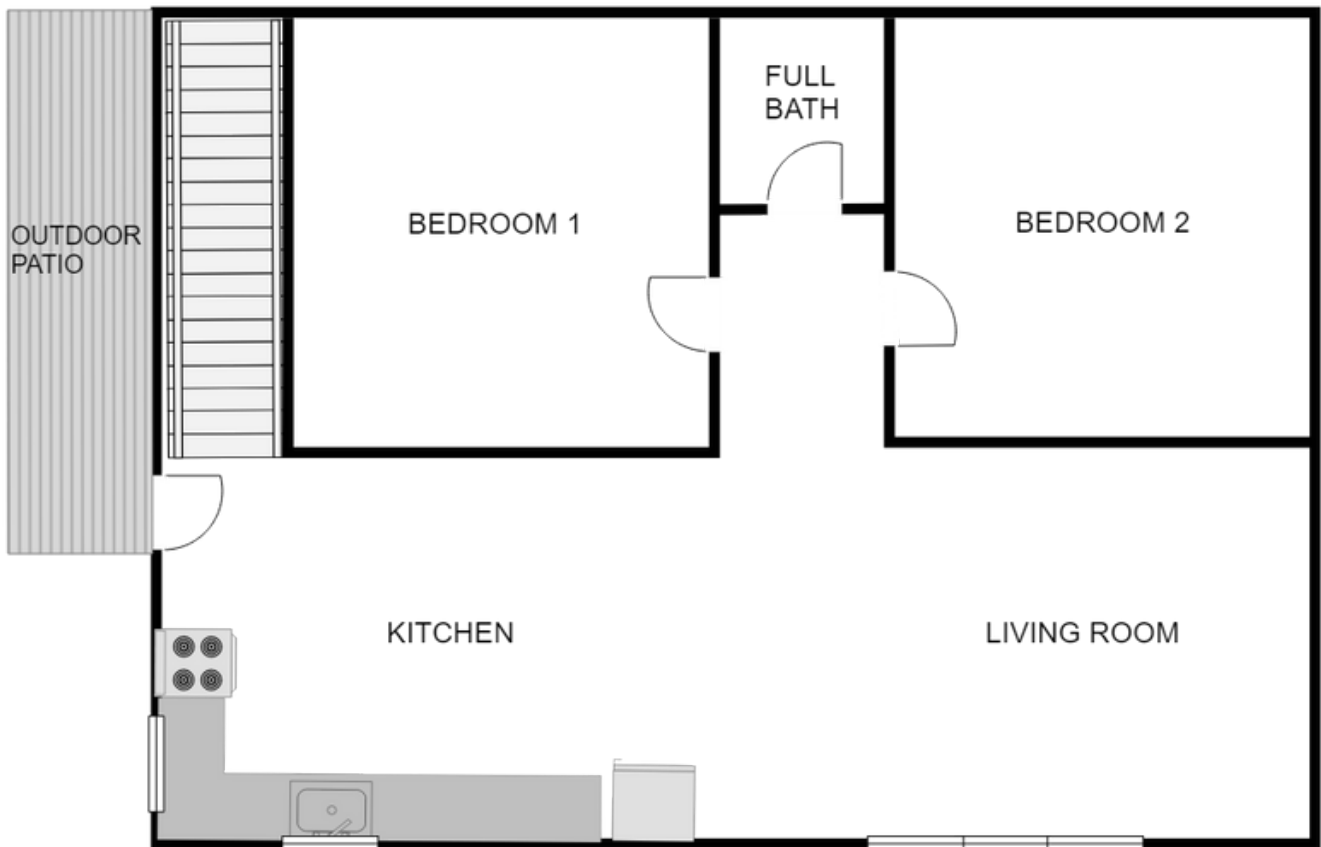
Main Level Bar & Restaurant

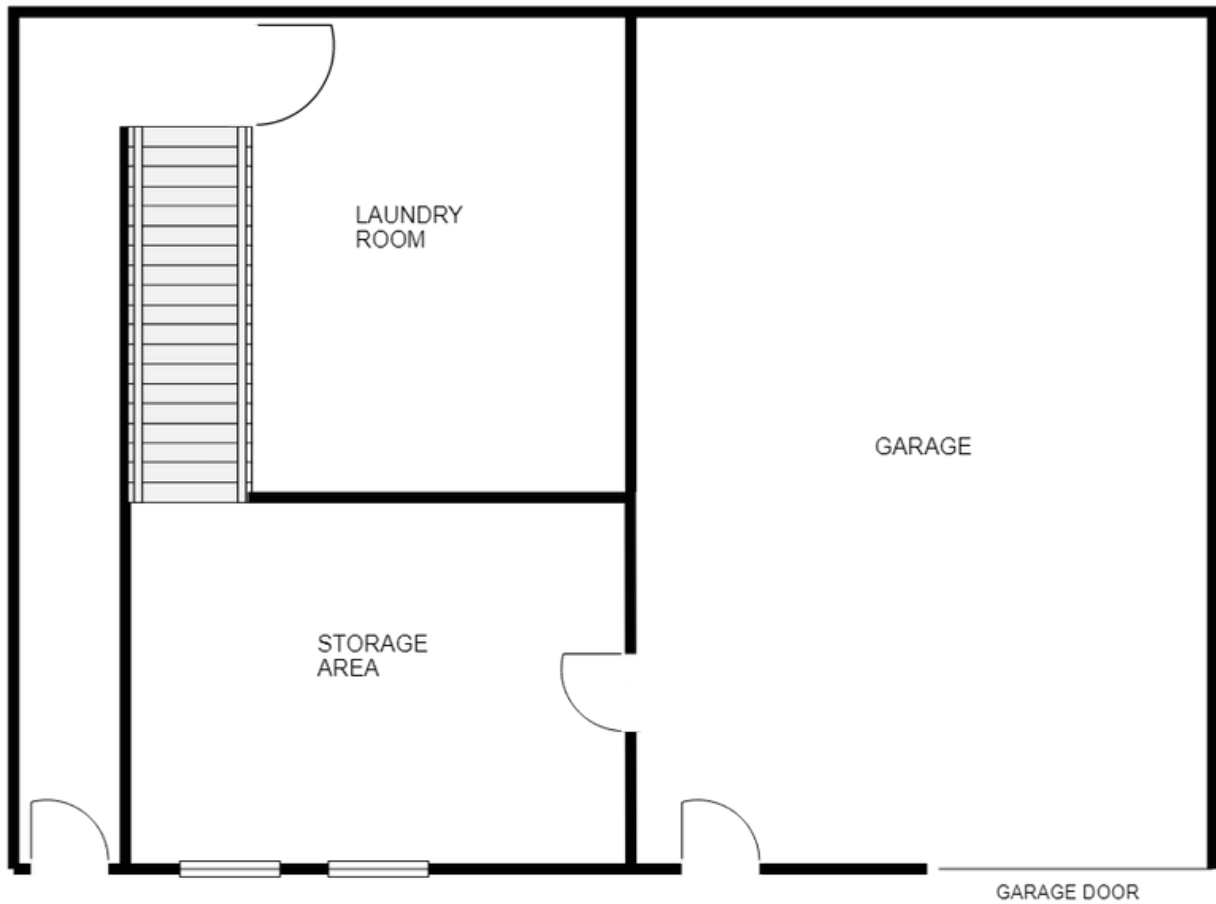
Upper Level Apartment

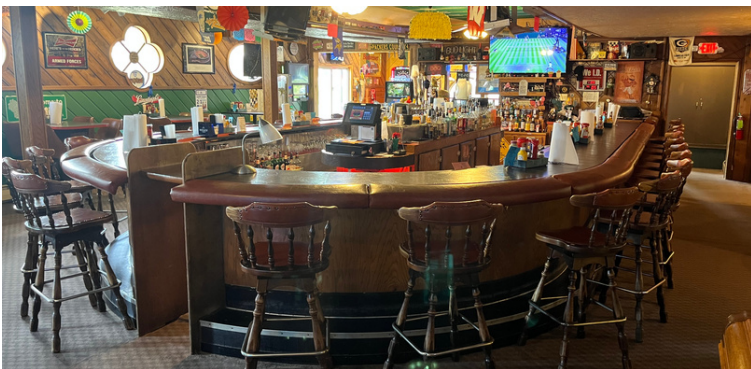
FLOOR PLAN

Lower Level Appartment



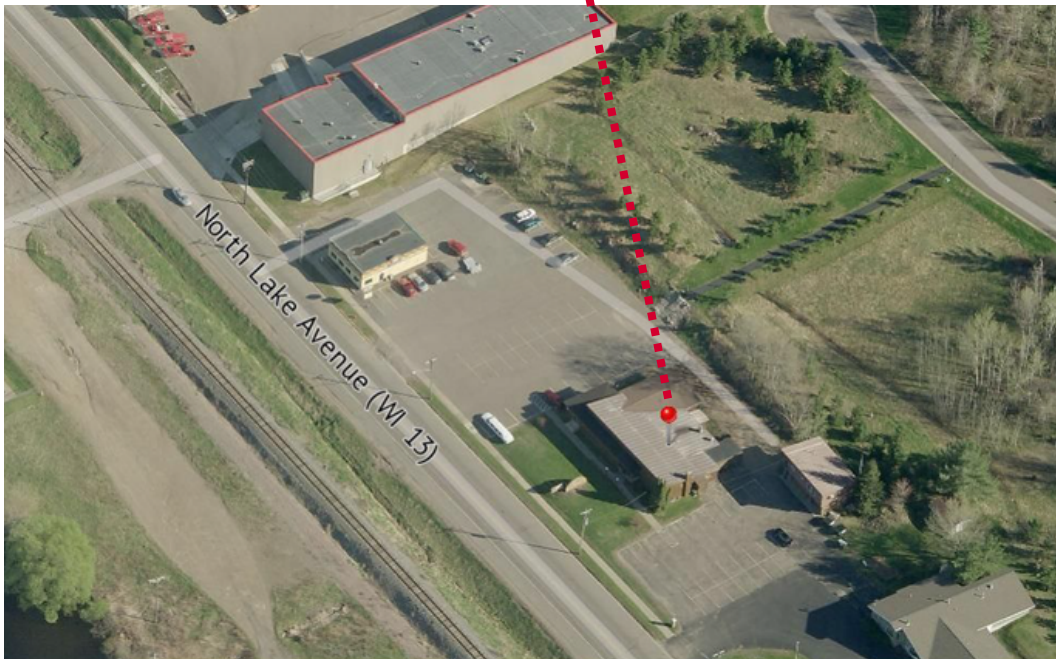
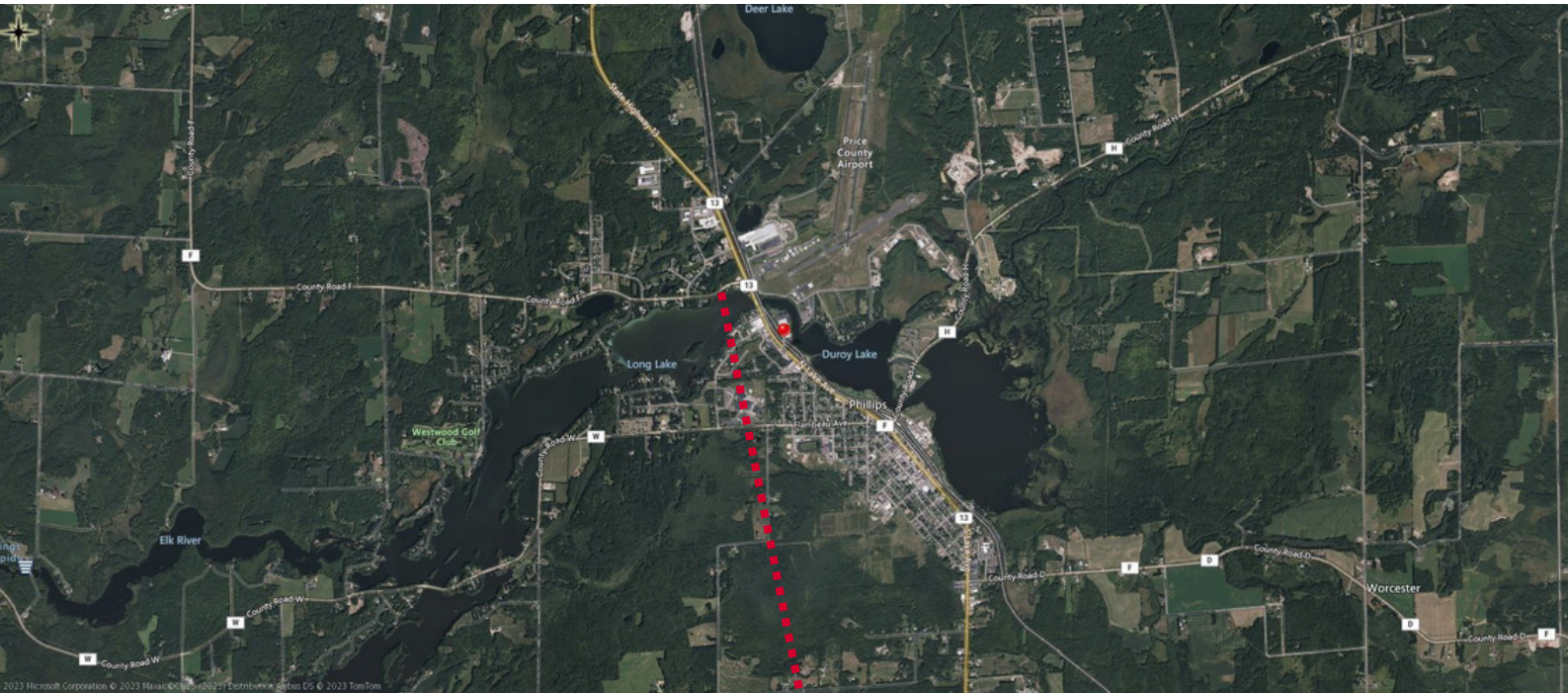

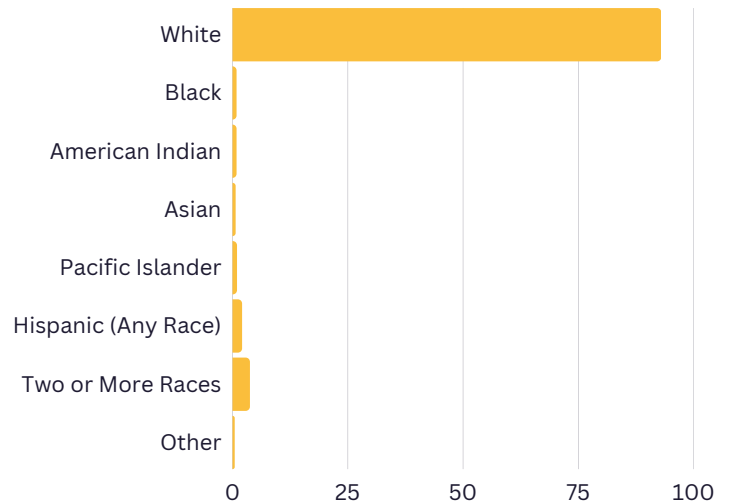
