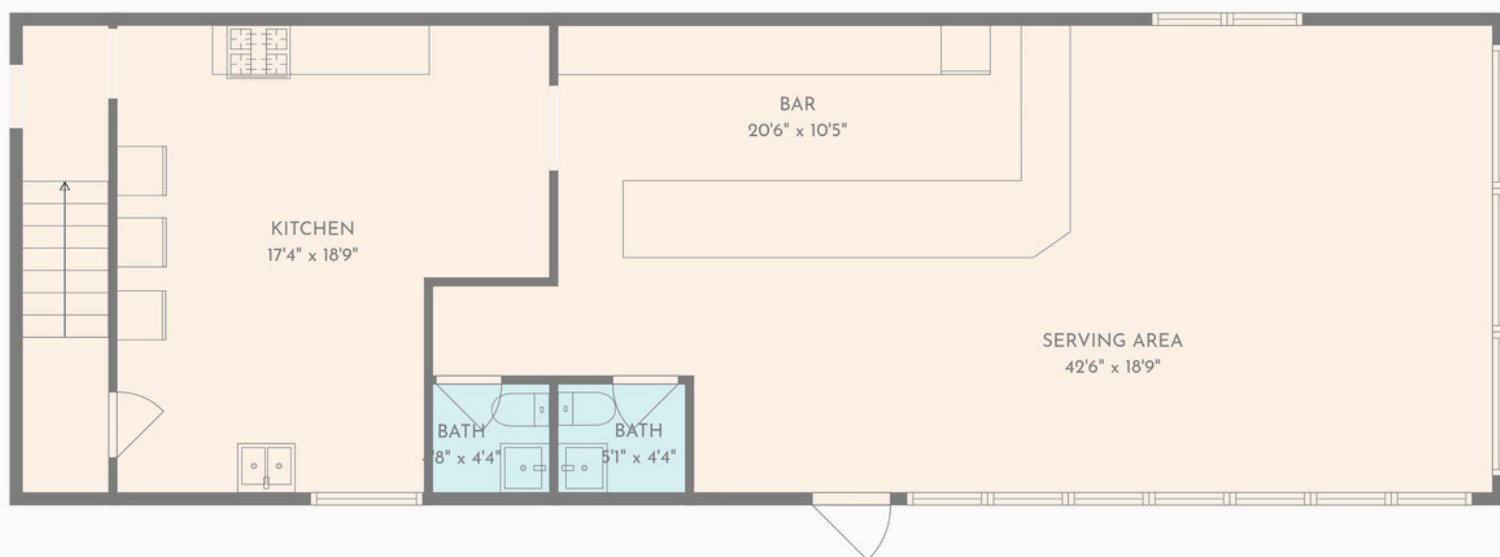

Tavern/Kitchen



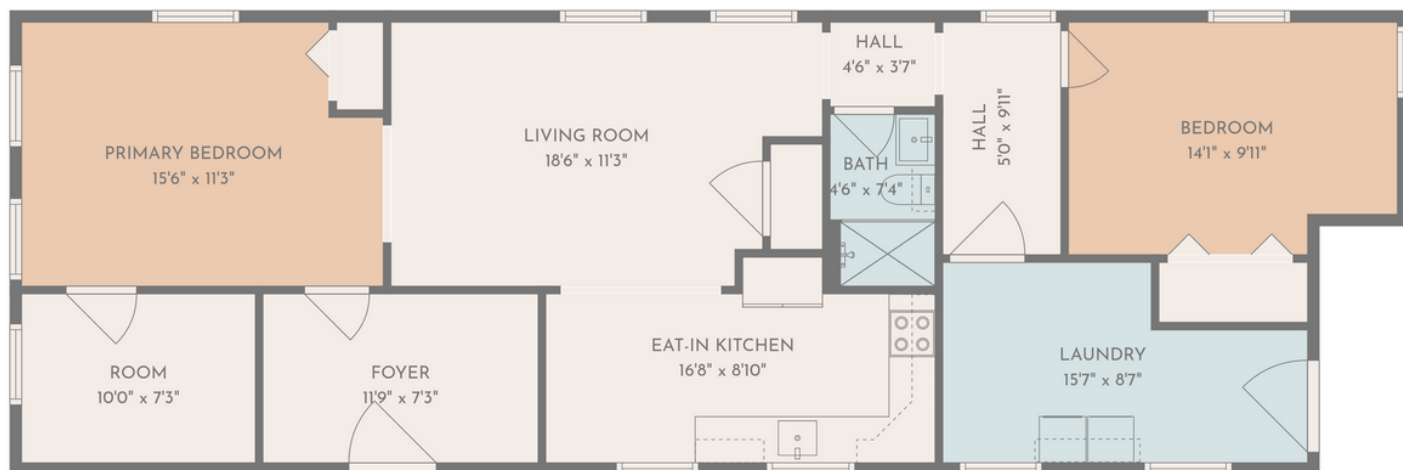

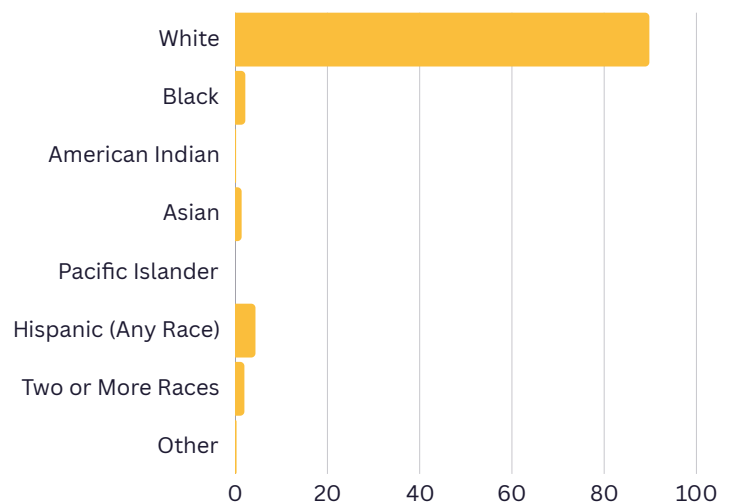
