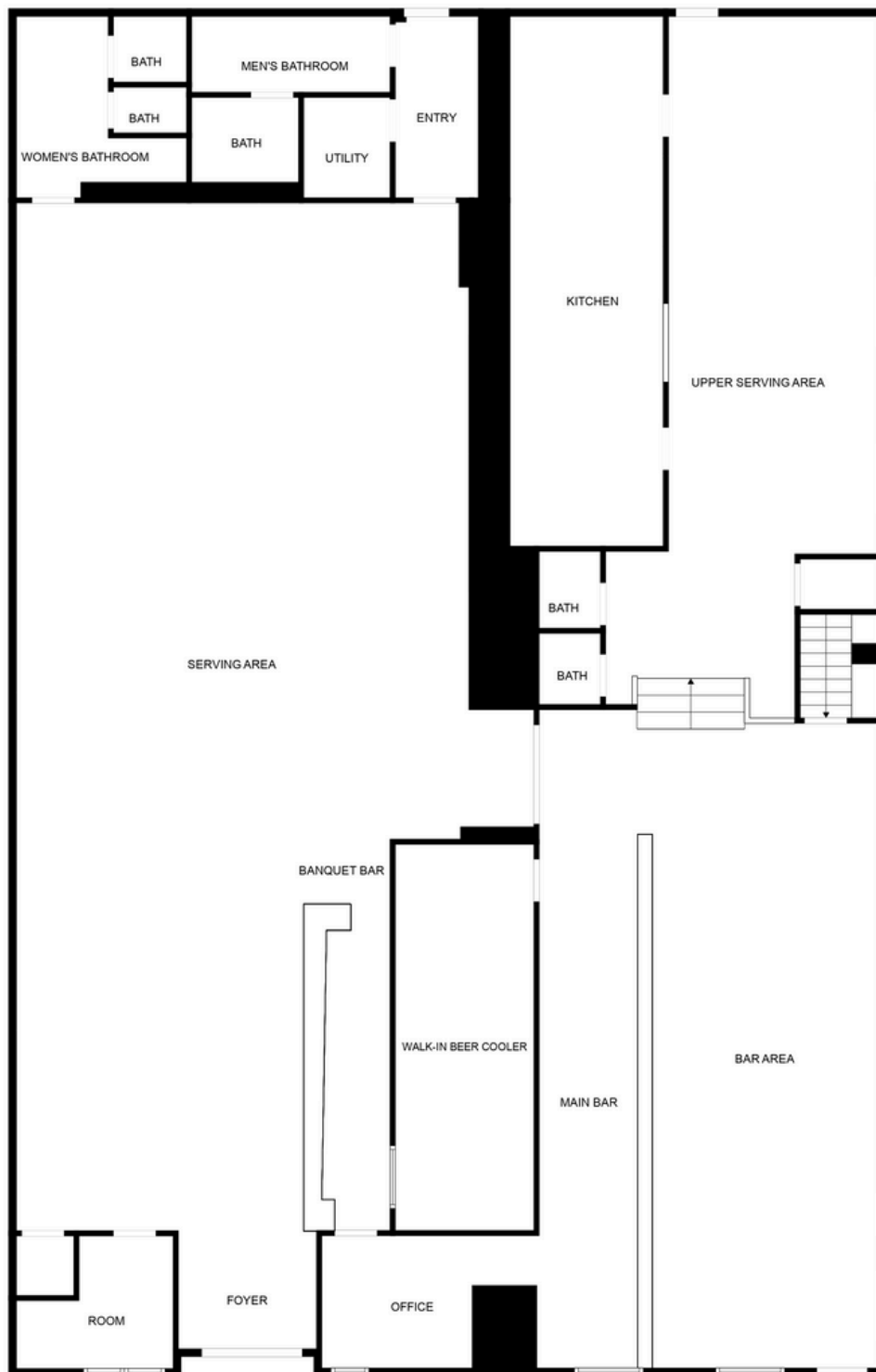

# FLOOR PLAN

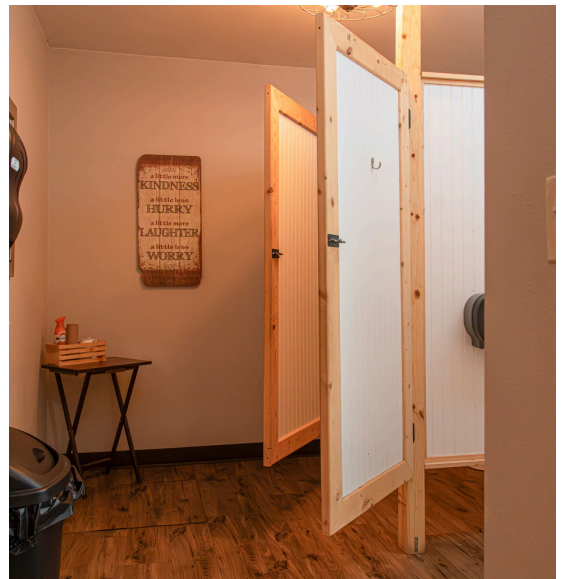
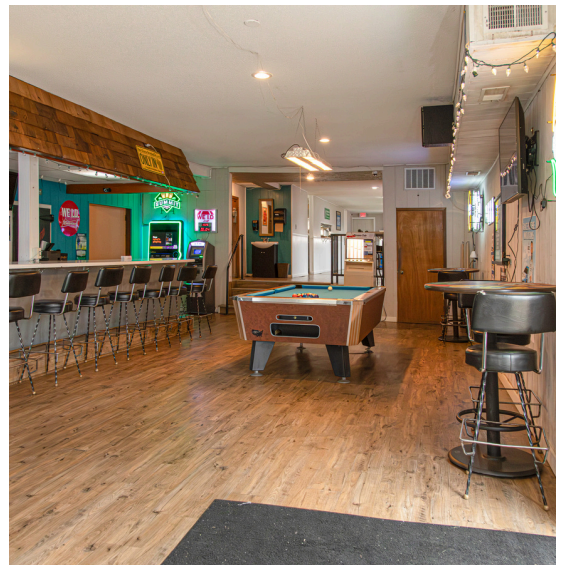
Main Floor

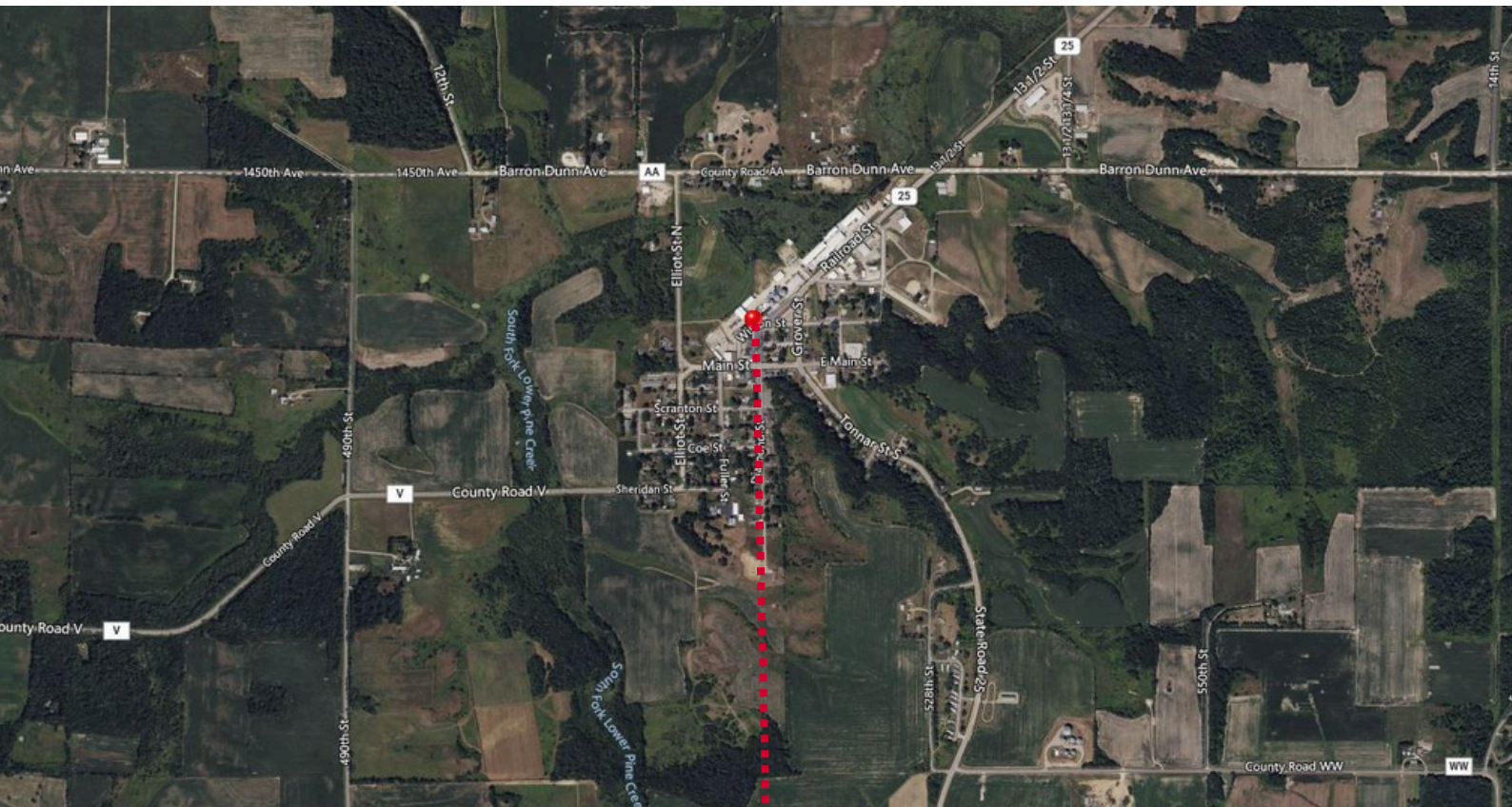

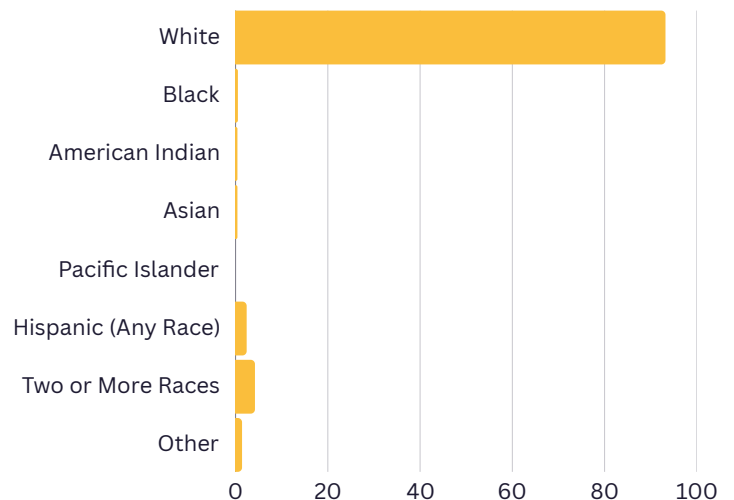
