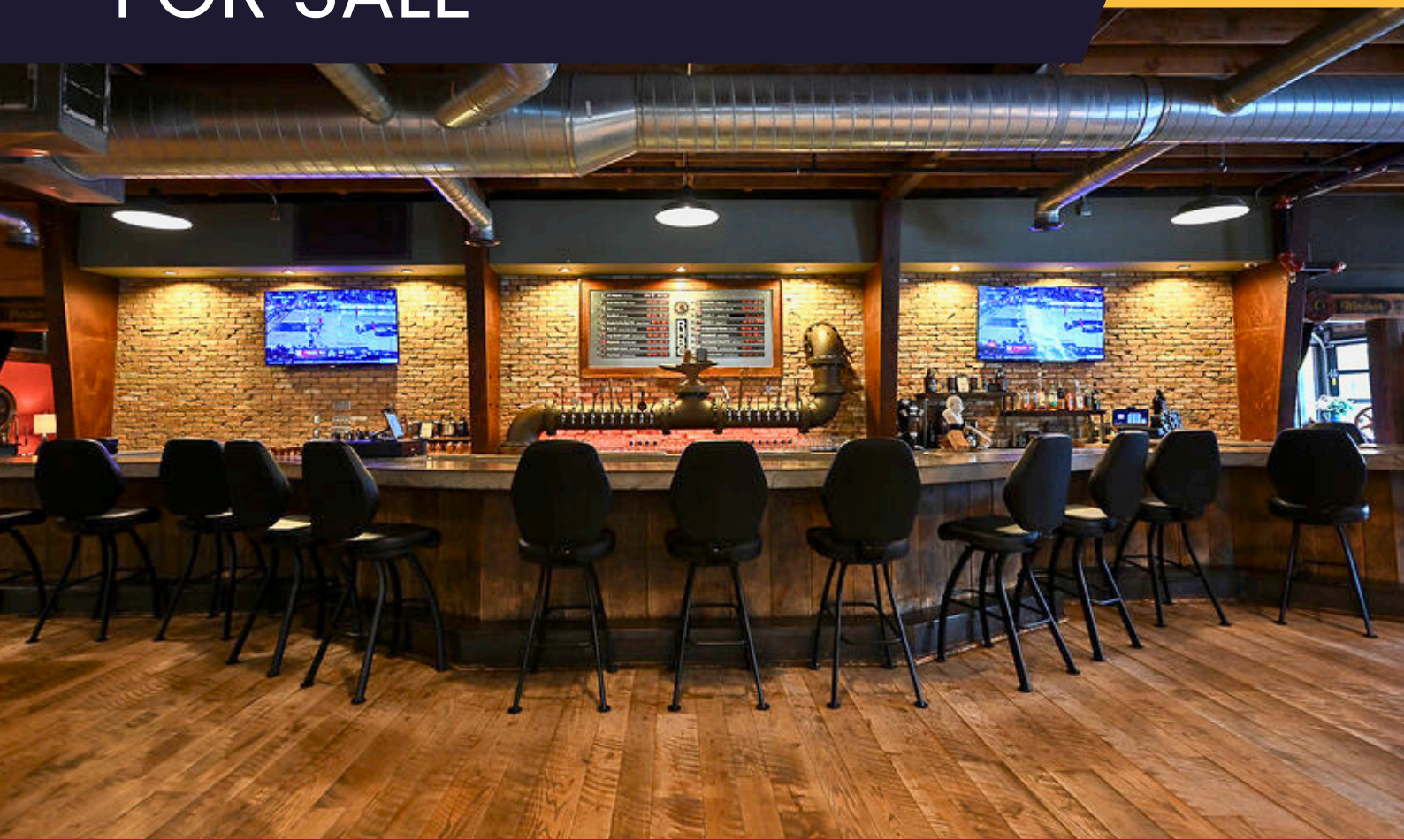

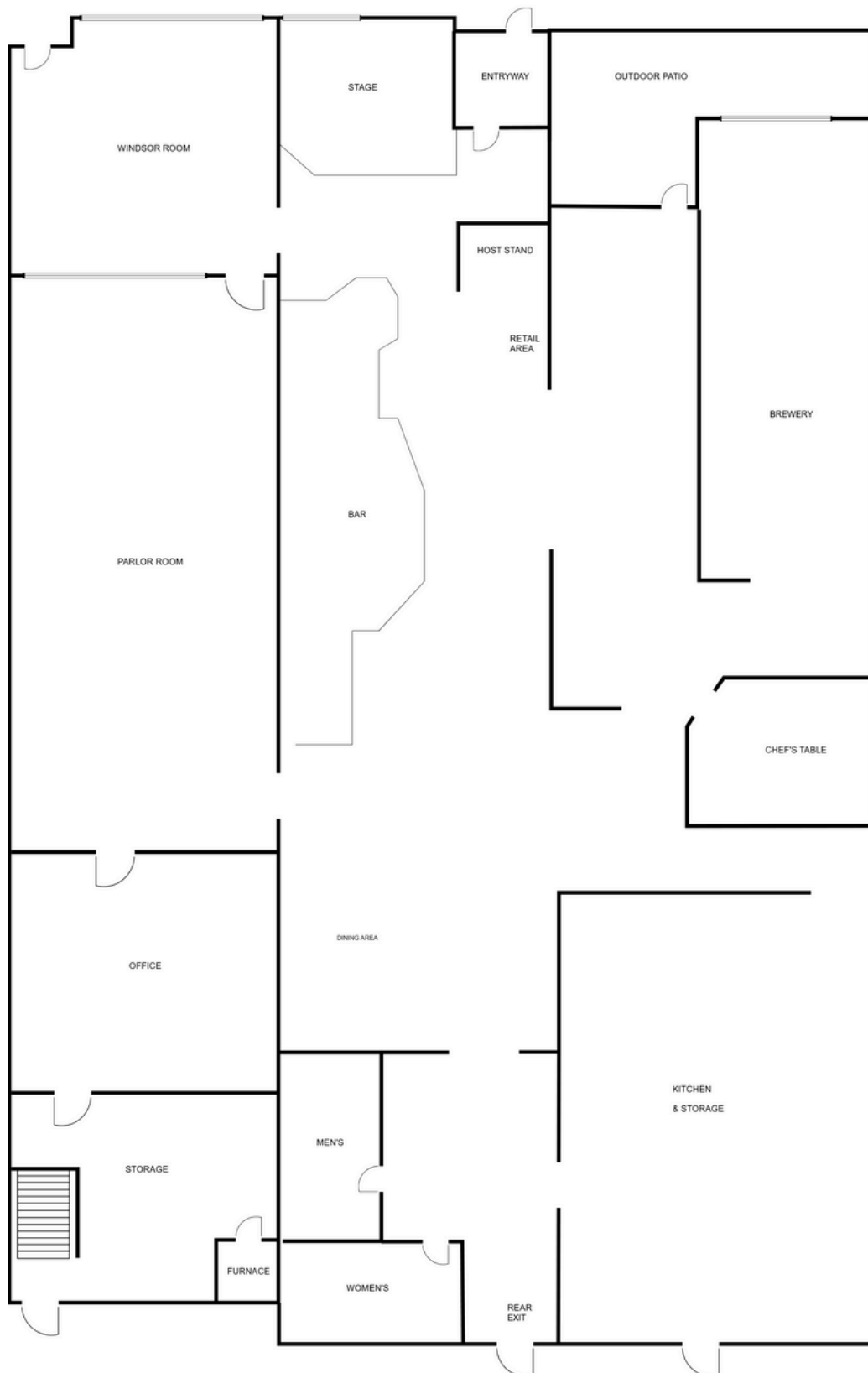
## PRIME LOCATION AND TURNKEY SETUP

# FLOOR PLAN

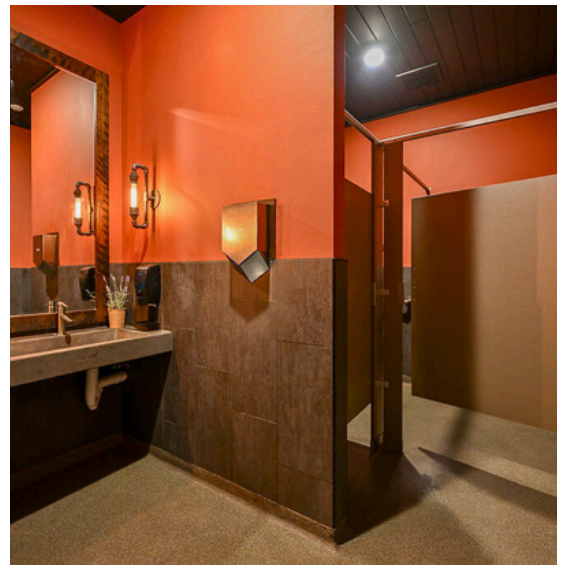

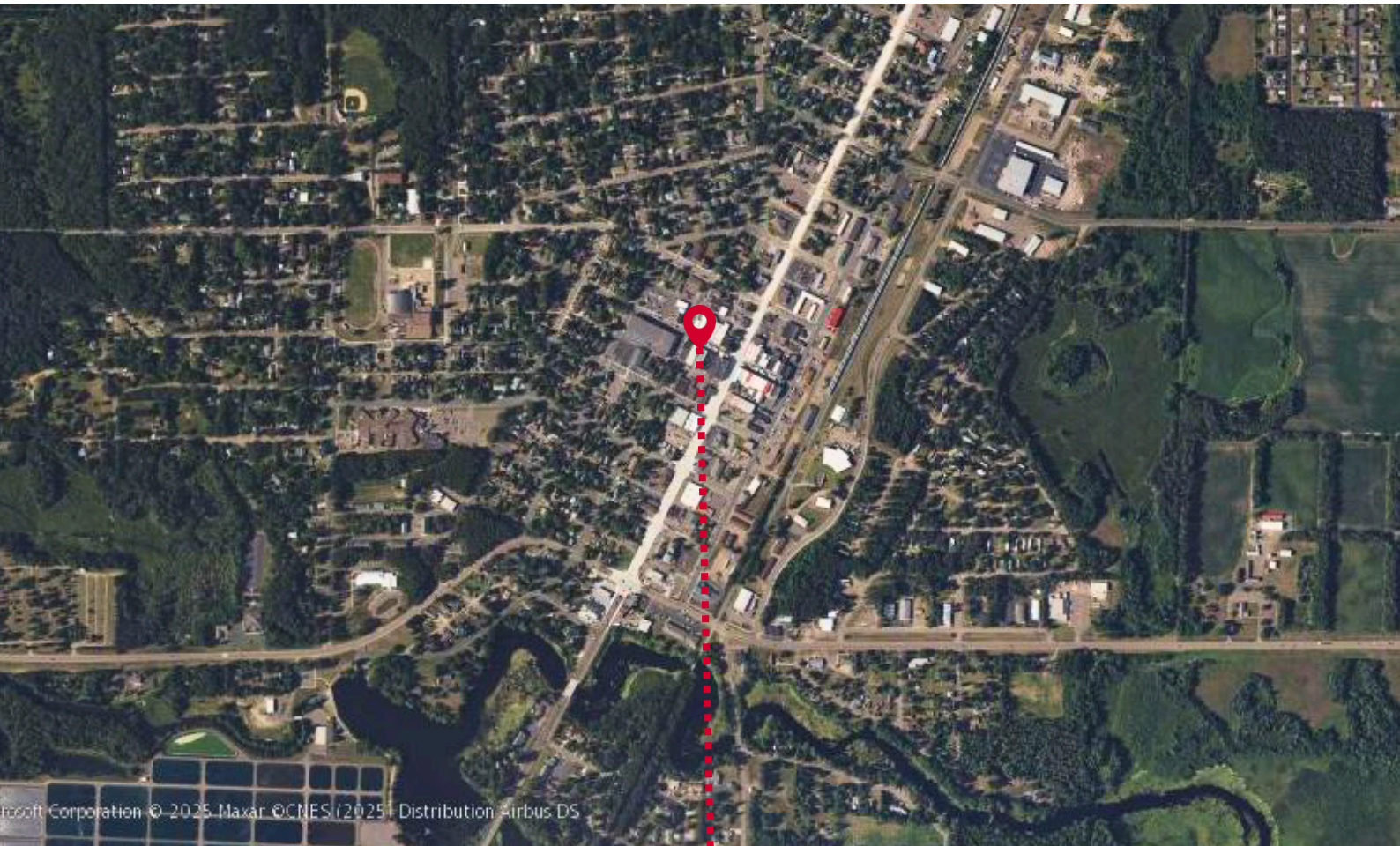
